a) EasyJet


Key figures and data:

- EasyJet impose fees varying on the route selected, flight and time of booking. They range from 5.99 £ (Approx 7.1€) and the maximum amount is not indicated¹. With regards to fees for hand baggage applied directly at the airport, a single fee, called Airport bag fee, of £48 € is applicable².
- Number of passengers potentially affected in 2024 only: 89.7 million³.




Figure 2: EasyJet – Booking process highlighting consumers that they only benefit from a "small under the seat hand luggage" and of the consequences for non-buying an extra (48 pounds or 58€ per extra luggage depending on the language).



b) Norwegian Air Shuttle Airline

- Norwegian Airline applies fees depending on the routes (for domestic flights, they can be up to 12.90 €/£ and for international flights between 14.90 and 24.90 €/£⁴. Bags are charged per item, per leg.
- Number of passengers potentially affected in 2024 only: 27.75 million⁵.


c) Ryanair

Key figures and data:

- Ryanair applies fees depending on the route and selected travel dates. Fees may also depend on whether they are added during the booking process or at a late stage, at the airport. They range from €/£6 €/£36 at the time of the booking and €/£20 - €/£60 post booking/at the Airport", respectively (Priority & 2 Cabin bags)⁶⁷.
- Number of passengers potentially affected in 2024 only: 197.1 million8.





Figure 6: Ryanair "Table of Fees" in their Terms and Conditions - (<u>Link</u> last consulted on 18 March 2025)



d) Transavia

- Transavia applies fees depending on the destination and the availability of the fare, flight and time of booking⁹. For Transavia flight numbers starting with "HV" (operated by Transavia Airlines C.V.), rates range from €14
 €32 per one-way trip. For Transavia flight numbers starting with "TO" (operated by Transavia France S.A.S.), rates start from €23 per one-way trip and from €39 on flights to/from Senegal.
- The rates for adding a cabin bag at the check-in counter for Transavia flight numbers starting with HV range between €29 and €47 per one-way trip. The rates for adding a cabin bag at the check-in counter for Transavia flight numbers starting with TO start from €60 per one-way trip.
- Number of passengers potentially affected in 2024 only: 9 million¹⁰.




Figure 8: Prompts on consumers encouraging them to pay for an additional "hand luggage" emphasizing the consequences if consumers bring a second piece of hand baggage (extra of 65€ at the boarding gate).



e) Volotea

- Volotea applies varying fees depending on the destination, booking date, or whether services are added during the booking process or subsequently at the airport. Only consumers who subscribed to Megavolotea (69.99€/year) and Megavolotea Plus (139.99€/year) have a "cabin baggage 10kg" included in the basic ticket fare. Otherwise, consumers must add a "priority boarding from 9€" and are forced to bundle additional services. Bringing a "cabin bag" into the cabin without priority boarding costs €65 per passenger and per flight (130€ extra in total)¹¹.
- Number of passengers potentially affected in 2024 only: 36.8 million¹².






Figure 11: Volotea - Prompt pushing consumers to buy an extra "10kg trolley" and emphasing the possible consequences of not buying it (65€ extra per passenger per flight).




HAND LUGGAGE WITHOUT PRIORITY BOARDING

One small bag in the cabin is included for each passenger.



Measurements for your small bag

It will go under the seat in front and must measure no more than 40 (height) x 30 (width) x 20 (depth) cm.



i Regulations on liquids (100ml)

Remember that liquids in your toiletry bag must travel in bottles containing no more than 100 ml.



Print Remember that you can only bring one small bag with you.


The cost of bringing a cabin bag into the cabin without priority boarding is €65 per passenger and per flight.

f) Vueling

- Vueling apply fees depending on demand, the route and selected travel dates, and also depending on whether they are added during the booking process (between € 10 and € 59 per item and flight), through Customer Service (between €10 and €59 per item and flight)¹³ or subsequently, at the airport (between € 45 and € 75 per item and flight at check-in desk)¹⁴.
- Vueling also implements dark patterns by promoting the most expensive option « Fly Grande » ticket during the booking process (see Figures 13 and 14). In our assessment, this website default design and interface constitutes a manipulative practice that materially distorts or is likely to distort the economic behavior of an average consumer and breach the trader's professional diligence requirements (Article 5 UCPD) and amount to a misleading practice (Article 6 UCPD). This is exacerbated visually highlighting with in yellow the most expensive option.
- Number of passengers potentially affected in 2023 only: 36.8 million¹⁶.

¹⁵ As recognized in the 2021 UCPD Guidance: "Default interface settings have a significant impact on the transactional decision of an average consumer. Traders could not only influence consumers to take certain actions, but also take specific actions in their place, for example by using pre-ticked boxes, including to charge for additional services, which is prohibited under Article 22 of the CRD. Such practices can also breach the UCPD as well as data protection and privacy rules" – Section 4.2.7. Data-driven practices and dark patterns.




Figure 15: Successive prompts on consumers to buy an extra piece of baggage, some emphasing the consequences for not doing it (75€ extra costs)






Figure 16: Vueling - Description of "under the seat cabin bag" and "luggage in overhead locker" on carrier's website



g) Wizzair

- Wizzair applies fees for hand baggage <u>depending on the selected travel dates</u> and on whether they are added during the booking process through the WIZZ Priority passengers' option, through the WIZZ Call Centre or subsequently, at the airport. According to Wizzair, "prices shown are per flight and averaged over all flights" and can be up to 60€¹¹. At the airport it would cost €65.00¹¹8.
- Number of passengers potentially affected in 2024 only: 62.8 million¹⁹.

¹⁷ During the testing conducted in the context of this complaint, we have seen a great price variation depending on the route selected by consumers. For a return flight Charleroi-Bruxelles-Sud – Koutaïssi, the Wizz Priority Option was of 21€ per flight (42€ in total). 


Figure 19: Examples of what constitute a "carry-on bag" of 40x30x20cm.
